At the Faculty of Law of Gottfried Wilhelm Leibniz University of Hannover he also achieved his Dr. iur. (2011) as well as his Habilitation (2023).

Having served at the Faculty of Law of Gottfried Wilhelm Leibniz University of Hannover as an Assistant Professor (=Habilitation) since 2017, after his Habilitation he is now a Privatdozent (Associate Professor) at the same Faculty (Hannover).

Dimitrios Parashu teaches European, Economic and Comparative Law at the same Faculty (Hannover), having done so on various occasions of guest professorships in Europe, America, and Asia.
